GOVERNORS' REPORT

The Governors present their annual report together with the financial statements and auditor's report of the charitable company for the year 1 September 2019 to 31 August 2020. The annual report serves the purposes of both a Governors' report and a directors' report under company law.

The trust operates an educational academy for pupils aged 13 to 18 serving a catchment area in Evesham and the outlying area. It has a pupil capacity of 1,377 and had a roll of 1,268 in the school census on 3rd October 2019.

Structure, governance and management

a. Constitution

The Academy is a members limited liability company and an exempt charity. The charitable company's Memorandum of Association is the primary governing document of the academy trust. The Governors of The Prince Henry's High School Academy Trust are also the directors of the charitable company for the purpose of company law. The charitable company is known as The Prince Henry's High School Academy Trust.

In this report there are frequent references to trustees. This is the same body of people as both the directors of the company and the 'governors' of a single academy trust; these words are used interchangeably. They are the people responsible under the academy trust's articles of association for controlling its management and administration. They have responsibility for directing its affairs, and for ensuring that it is solvent, well run, and delivering the trust's charitable outcomes for the benefit of the public.

Details of the Governors who served during the year, and to the date these accounts are approved are included in the Reference and administrative details on page 1.

b. Members' liability

Each member of the charitable company undertakes to contribute to the assets of the charitable company in the event of it being wound up while they are a member, or within one year after they cease to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a member.

c. Trustees' indemnities

The Academy provides indemnity insurance to cover the liability of Governors which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default, breach of trust or breach of duty of which they may be guilty in relation to the Academy.

d. Method of recruitment and appointment or election of Governors

A minimum of three and a maximum of four Governors are elected by the parental body as Parent Governors.

The Head of the school is a Governor.

Two of the Governors are elected by the staff of the school as Staff Governors.

A minimum of three and a maximum of six Governors are nominated by the members as Community Governors.

A minimum of two and a maximum of four Governors are nominated by the members as Partnership Governors.

For any Governor, other than Staff Governors, prior to taking up the post, references will be sought by the Clerk and presented to the Governor Appointments Committee. This is to ensure that students are further safeguarded and potential conflicts of interest are avoided.

The Governors are aware of the requirements within the Academies Financial Handbook 2019 and 2020 suggesting that the majority of Members should be independent of the Governing Body. The school is working towards this.

e. Policies adopted for the induction and training of Governors

Training and induction for Governors will depend on their prior experience and/or knowledge. Most induction is carried out "in house", but external trainers may be brought in, or Governors may attend external training provision as appropriate. Governors are provided with copies of all the documents that they will need to undertake their role.

f. Organisational structure

The Governing Body is responsible for managing the Academy on behalf of the Trust. It provides oversight and strategic direction for the Academy and does so through a robust governance and decision-making process, which includes regular meetings, debate, review of working papers and strategy discussions. Financial Management and oversight is managed through strict adherence to the guidance provided by the ESFA through the latest version of its Academies Financial Handbook and by following the relevant guidance provided by the Charities Commission and HM Treasury Managing Public Money guidance.

The Governing Body continues to be advised by their legal representatives Browne Jacobson to ensure that the Articles of Association remain up to date and appropriate bearing in mind potential changes to both national and local educational structures.

The key responsibilities of the Governing Body are to:

- Ensure the quality of educational provision
- Challenge, monitor and support the performance of the school
- Manage the Trust's finances and property and assets
- Manage the Headteacher
- Exercise reasonable skill and care in carrying out their duties
- Ensure that the Academy Trust complies with charity and company law
- Operate the Academy in accordance with the Funding Agreement that has been signed with the Secretary of State

To deliver to these broad responsibilities the Governing Body delegates, through explicit Terms of Reference, a number of its responsibilities to three key Committees as follows:

- Finance, Risk and General Purposes – in accordance with the Academy Financial Handbook 2020, committee renamed Audit & Risk with updated Terms of Reference to be effective from 1st September 2020. For the purposes of this report, it will be referred to as Finance, Risk & General Purposes (FR&GP);
- Safeguarding, Health & Safety, Insurance and Property – in accordance with the restructuring and renaming of FR&GP, this committee will be renamed Safeguarding, Property and General Purposes from 1st September 2020, with updated Terms of Reference. For the purposes of this report, it will be referred to as Safeguarding, Health & Safety, Insurance and Property (SHIP);
- Academic, Pastoral and Teaching

Other Committees which meet as required are:

- Audit and Planning
- Strategic Consultation Group
- Governor Appointments
- Salaries & Appointments
- Staff Committee
- Pupil Admissions Committee

The Statutory Appeal Committees, which meet as necessary, are: Exclusions, Complaints and Conduct; Staff Appeals; and Independent Appeals Panel.

All Committees report to the Governing Body as set out in their Terms of Reference, meet on an agreed schedule and on an as required basis, report to and where necessary, ask the Full Governing Body to approve decisions made in the Committees.

The Governing Body delegates executive responsibilities for maintaining, running and developing the Academy to the Head and his Senior Leadership Team. All delegated Leadership responsibilities are articulated in appropriate job descriptions and formal authority documents. All delegated Leadership responsibilities are recorded formally through the weekly Senior Leadership Team meetings. These are monitored through the Academy's System and Control procedures, its Risk Management structures and Internal Control Framework and are subject to regular scrutiny and audit.

g. Arrangements for setting pay and remuneration of key management personnel

Since 1st September 2018, the Academy has implemented its own Pay Scales.

As set out in the Academy's Pay Policy, the Governing Body has established pay ranges for the Headteacher, Deputy Headteachers and Assistant Headteachers. All decisions concerning pay and remuneration are made by the Salaries and Appointments Committee and ratified by the Full Governing Body. Benchmarking exercises are regularly carried out by the Salaries and Appointments Committee and an independent School Improvement Partner is used to support the setting and review of performance targets for the Headteacher.

i. Connected organisations, including related party relationships

During the period the Academy's SCITT had 13 trainees. There were some related party relationships, which are acknowledged at the Governors' meetings through the pecuniary interests forms, and any financial transactions are disclosed in the notes to the accounts.

The Academy has in place a trading company and this is a wholly owned subsidiary of the Academy.

a. Objectives and Activities

OBJECT AND AIMS

The Academy's main object is set out in its Articles of Association and referred to in pages 5-12 of that document. In summary, the principle object is to create and develop the very best Teaching and Learning environment for all our students and staff based upon the virtues of sound traditional values; thus enabling our students to leave Prince Henry's as well rounded young people with a first class outstanding education that becomes fully embedded and integrated into their future lives.

We aim to achieve this by:

- Recruiting teachers to Prince Henry's who represent excellent traditional role models: highly qualified, courteous, professional, and happy to help all students at all times
- Ensuring Prince Henry's staff instil into our students the universal values outlined on our website
- Ensuring the facilities and resources available are suitable and well maintained for an appropriate teaching environment
- Providing a modern, broad, balanced, relevant and sustainable curriculum, so that our provision supports the individual needs of all of our students
- Listening and responding appropriately to any parental queries on a personal basis, and supporting parents and carers with their child's journey through Prince Henry's
- Recruiting new entrants to the teaching profession and providing high quality CPD through our SCITT and Teaching School
- Supporting and learning from other schools that we work with through the School to School programme of the Teaching School
- Being relentless in the quest for outstanding continuous improvement in all areas of Prince Henry's High School

In accordance with the Articles of Association, the academy has adopted a Funding Agreement approved by the Secretary of State for Education. The Funding Agreement specifies, amongst other things, the basis and requirements for admission of students, and that the curriculum should comply with the substance of the National Curriculum.

b. Objectives, strategies and activities

To help with the objects and aims above, during the 2019/20 academic year, the Academy set aspirational aims and objectives as follows:

- To obtain pupil outcomes and academic results as detailed in our School Improvement Plan
- To monitor and refine curriculum provision in light of new curriculum changes
- To prepare the school for changes to assessment so that each pupil's Progress 8 and Attainment 8 measure is maximised
- To intensely focus upon Disadvantaged Pupil Progress
- To ensure that outcomes in MFL are maximised
- To embed a smooth transition to a new linear curriculum where most pupils will study 3 A levels (refining induction processes so that pupils are choosing sensibly and retention levels are high.)
- To focus upon the leadership of the new Citizenship GCSE in Years 9 and 10. Continue to monitor the delivery of PSHE curriculum including British values.
- To continue to improve the school site to create a better learning environment for our students.
- Providing the Leadership and Management structures to oversee the significant cuts to the budget and delayed implementation of the National Funding Formula
- To continually review the pay award structure for all staff at the school
- To ensure that SLT, Staff and Governors are aware of the latest advice and guidance on Safeguarding priorities.
- To develop a focus upon how students are rewarded within school.
- To embed the House structure across the whole school.
- To continue to develop our alternative provision in the school through The Lodge and The Bridge
- To continue to focus intensely upon student outcomes, particularly for Disadvantaged Students, so that their outcomes are maximised.
- To ensure that our third cohort of SCITT students is successful.
- To continue to improve processes for developing self evaluation and school improvement.
- To construct the D&T block.
- To enhance car parking on the site.
- To further improve the quality and sustainability of the staff through appropriate or targeted professional development.
- To develop the Arts Theatre.
- To ensure students and staff are able to work in an environment that is COVID safe.
- To ensure appropriate planning is in place to ensure students are able to re-engage with their learning during lock-down and post lockdown in 2020.
- To make a bid for Teaching Hub status to enhance ITT, CPD and ECF provision.

The strategies and activities of the Academy were as follows during the 2019/20 academic year:

- The school ensured that high quality remote online provision continued during lock-down,
- The school ensured that it was COVID secure for return of pupils and staff through high level Risk Assessment.
- The school was refurbished - Sixth Form, The Grove, Abbey, Arts Theatre, LED lighting throughout.
- Timings of the school day were adjusted so that the students could receive learning safely in school.
- The school rapidly implemented new curriculum changes and robust mechanisms for determining Centre Assessed Grades so that the overall 2019/20 achievements were of the highest integrity.
- There were very positive results at A-level and GCSE.
- We saw pleasing gains in the performance of our Disadvantaged Students, as outlined in our online Pupil Premium Strategy, which can be accessed on our website via the General Info/Statutory Information/Pupil Premium section.
- We provided an extensive and wide-ranging programme of CPD for staff

- We enhanced the curriculum provision for our students receiving Alternative Provision.
- We continued to enhance Prince Henry's as a Teaching School, as detailed in the Teaching School Year Six Evaluation, which was sent to the DFE, and we began our planning process to bid for a Teaching School Hub.
- The school surpassed all targets for the fifth year of Teaching School, and was re-accredited with sixth year funding during the summer of 2019. The Headteacher chaired the Worcestershire Teaching School Alliance, and led a School Recovery Offer for Worcestershire schools. The Head also contributed to the NPQ programmes through the Worcestershire Global Leadership Academy (WGLA).
- We successfully trained 13 student teachers through our SCITT.
- We trained 2 Teacher Apprentices through our Teaching School Alliance.
- Successful external audits were undertaken into the financial management of the SCITT and SSIF.
- The school received a SRMA visit and the report was extremely positive highlighting that the school could not find any further efficiency savings demonstrating that the leadership of the budget was excellent.
- Enrichment, extra curricular opportunities and alternative provision continued to be developed positively, with regular updates on activities that have taken place being provided on our website.
- The school was re-accredited with the School Games Platinum award, Careers Mark.

c. Public benefit

In setting our objectives and planning our activities, the Governors have given careful consideration to the Charity Commission's general guidance on public benefit.

The Academy aims to advance for the public benefit, education in Evesham and the surrounding area. In particular, but without prejudice to the generality of the foregoing by estimating, maintaining, managing and development of schools, offering a broad curriculum with a strong emphasis on enrichment activities.

The Academy provides some facilities for recreational and other leisure time occupation for the community at large including the Arts Theatre and Sports Hall, with its astro turf and cricket coaching facilities. Bookings are taken from the community to take advantage of out of school hours' provision and the Academy is pleased to be able to play a part in improving social welfare and the life of the said community. Income from these facilities is managed via the Academy's Trading Company and is included in the school's accounts. Bookings for community facilities were strong up until the Covid-19 lockdown in March 2020. After lockdown, the Sports Hall re-opened for community bookings, and we have provisional bookings in place for the Arts Theatre for 2021 and 2022.

As an Academy we have a duty to support other schools. We have strong relationships with our feeder middle schools and with first schools in the local area. We also maintain a number of strong partnerships through our Teaching School Alliance.

During the 2019-20 school year, 1,268 pupils attended the Academy. Our catchment area includes:

1. Evesham north of the Avon ("the old town").
2. Evesham south of the Avon and west of the Isbourne ("Hampton").
3. Villages north of Evesham (Norton, Lenchwick, Harvington, Abbots Morton, Radford, the Lenches).
4. Villages around Bredon Hill (principally Charlton, Cropthorne, Elmley Castle, Bricklehampton, Eckington, Bredon, Kinsham, Bredons Norton, Westmancote, Overbury, Kemerton, Conderton, Beckford, Ashton).
5. South eastern villages (Hinton, Sedgeberrow, Aston Somerville, Childswickham, Broadway).

The majority of students come from St Egwin's CE Middle School (which serves 1, 2 and 3 above) and from Bredon Hill Academy (which serves 4 and 5).

Achievements and performance

The main achievement has been the maintenance of high academic standards, as evidenced by the published public examination results. A Level results were again very pleasing. More than 70% of students progressed to higher education, of whom over 35% went to Oxford, Cambridge, a Russell Group university or another of the universities in the Times' top 20 universities list. This included five students who were awarded places at Oxford or Cambridge Universities. More importantly, nearly every individual student progressed to an appropriate higher education course.

GCSE results were excellent. There is very strong evidence of pupils making very significant progress in terms of levels between national curriculum key stages.

a. Key performance indicators

Due to the implementation of Centre Assessed Grades and an algorithm for determining A Level and GCSE grades in summer 2020, the Worcestershire Association of Headteachers unanimously agreed that exam results with KPIs would not be published. Therefore, the A Level and GCSE results below are described in numeric form, in accordance with the school's published press releases.

A Level Results 2020

- The overall results for 2020 have once again been pleasing
- 155 students were entered for A Level or equivalent examinations
- 24 students achieved at least 3 A*/A grades
- Top performer achieved 4 x A* grades
- 5 students awarded places at Oxford or Cambridge

GCSE Results 2020:

- The overall results for 2020 have once again been pleasing.
- 302 students were entered for GCSE or equivalent examinations
- 21 students achieved the equivalent of an outstanding nine or more 7-9 numeric grades
- Top performer achieved ten Grade 9 results
- 64 students gained 5 or more 7-9 numeric grades.
- 222 students achieved 5 A*-C grades (including standard passes in Maths and English)
- 122 students achieved the English Baccalaureate
- 226 students achieved standard passes (numeric grade 4 and above) in both English and Maths

Other Key Performance Indicators

There are many other KPIs that the Governing Body reviews and scrutinises on a regular basis, which are written within the School Improvement Plan and SEF, including:

- **Attainment and Achievement Targets and Outcomes.** As well as internal assessments, important outcomes that are monitored by the Academic, Pastoral and Teaching Committee include cumulative percentages of grades at GCSE and A Level; published benchmark measures at A Level and GCSE; Attainment 8 and Progress 8; outcomes by students in receipt of Pupil Premium, outcomes by students with identified Special Needs.
- **The quality of behaviour and discipline,** monitored through engagement in the curriculum, lesson observations, attendance figures to school, exclusion rates, positive rewards and behaviour referrals.
- **The quality of the curriculum and provision,** including the information and guidance provided to match the needs of our students from Year 9 through to Year 13. This is monitored through the **Academic, Pastoral and Teaching Committee.**
- **The use of our financial resources** to provide value for money and a high quality learning environment through management and investment in: our school site, the curriculum provision on offer, the quality of teaching and the social and community dimensions that the school provides. This is monitored through the **Safeguarding, Health & Safety, Insurance and Property Committee** and **Finance, Risk & General Purposes Committee.**
- **The performance of colleagues** managed through Continuing Professional Development, Peer observation and Appraisal. This is reported to the **Finance, Risk and General Purposes, the Academic, Pastoral and Teaching, and Salaries and Appointments Committees.**
- **The School Improvement Plan and Self Evaluation** of Prince Henry's High School. This is led by the Senior Leadership Team and scrutinised and approved by the **Strategic Consultation Group of Governors.**

b. Going concern

After making appropriate enquiries, the Board of Governors has a reasonable expectation that the Academy has adequate resources to continue in operational existence for the foreseeable future. It has considered the impact of Covid-19 on possible scenarios relating to the budgets and future cashflows in making its assessment that the going concern basis is appropriate. For this reason, it continues to adopt the going concern basis in preparing the financial statements. c. COVID-19 Impact

Following the COVID-19 School Closure announcement by the government, the school closed to all pupils on 20th March for full time education. It remained open every day for vulnerable students and children of critical workers. Between 20th March and the end of the Summer Term, subject lessons were taught online through ShowMyHomework and Microsoft Teams.

Prior to the school closure, we had to take the difficult decision at the time to cancel a number of trips and events that the students had paid for. Unfortunately, the Berlin trip could not take place, and neither could the trip to Amsterdam. The RPA have fully funded the reimbursement of both of these school trips and full refunds were made to the families concerned.

The Safeguarding Team made regular contact with vulnerable students and this happened over the designated Easter and Whitsun holidays as well. Parents were also able to contact the school with any safeguarding concerns regarding their child on a daily basis, and reception was staffed every day to enable this. We updated our Safeguarding area of the website and our Home School Agreement and Safeguarding Policies during lockdown which were published there.

During the COVID period, cleaning at the school was substantially enhanced and continues to be.

The Headteacher provided regular updates to parents which were published on a separate area on the website. The Senior Team ensured the whole community were engaged with online Assemblies so that the values of the school during the pandemic were reinforced. The Senior Team were constantly responding to announcements made by the government and dealing with the anxiety of students and parents about GCSE and A-level outcomes. The students received their A-level and GCSE results on 13th and 20th August respectively.

The teaching staff balanced priorities with their own children in trying to support Prince Henry's students through online lesson delivery. The school received considerable positive feedback from the parents, and we maintained effective systems for referring non-completion of homework and passing on safeguarding concerns. The school completed online assessments for students with EHCPs and monitored our vulnerable students through The Lodge and The Bridge.

The ESFA build project for the D&T building continued and approximately 24 classrooms and surrounding corridors were re-decorated. The Sixth Form Office and Common Room was also re-furbished and LED lighting was installed across the school. We were also successful in receiving a CIF bid to repair roofs.

The Chairman of Governors and Committee Chairs were available by phone and through virtual meetings during the initial period of closure- 20th March until 1st June. The Governing Body supported the Senior Leadership Team in producing a Risk Assessment for re-opening following the release of government guidance. In addition to the Risk Assessment for re-opening, governors provided challenge and support for decisions concerned with Safeguarding, the closure of the Arts Theatre during COVID, and also with the process for determining Centre Assessed Grades.

During the period of lockdown, we continued to recruit to the SCITT, and we had 22 trainees begin with us in September 2020.

The school held an online Music Concert, Speech Day and set up a dedicated area on our website focussed upon the acts of kindness that we have seen through our school community.

The Chairman of Governors attended three staff meetings prior to the school re-opening and on behalf of the

Financial review

a. Reserves policy

Governors determine what the level of uncommitted reserves should be. Unfortunately, due to the current uncertainty of future Sixth Form funding and the potential consequence of the removal of teachers pay and pension grants in 2021-22, the Governors have agreed that elements of the reserves be used to support the school's day-to-day operations and encourage an ongoing programme of cost saving whilst maintaining a level of reserves which can help mitigate eventualities which could place the school at risk. This is currently planned to be equal to at least one month's operational costs, approximately £480,000. Currently the school holds approximately £443,000 in reserves.

Once confirmation is received on the scope and quantum resulting from the new Funding Formula, the aim is to maintain reserves at a level so as to provide sufficient working capital to cover delays between spending and receipt of grants and to provide a cushion to deal with unexpected emergencies such as urgent maintenance.

As a part of its monitoring of in year financial performance, the Governing Body reviews the forecast impact on reserves and considers this as a part of its medium term financial planning. As at 31 August 2020 the school held total general funds of £443,000 which it plans to use in part as a component of that medium term financial plan.

Under Accounting Standard FRS102 it is necessary to charge projected deficits on the Local Government Pension Scheme that is provided for non-teaching staff to a specific restricted reserve. As at 31 August 2020 the deficit on this reserve amounted to £2,839,000. It should be noted however that this does not present the academy with a current Capital or Liquidity problem. Contributions to the pension scheme are being budgeted over the next few years in order to reduce the deficit.

Unrestricted funds show an acceptable surplus of £396,000 (2019: £314,000) which is in line with academy budgets and objectives.

b. Material investments policy

The Headteacher together with the Finance Manager will ensure that any surplus funds are deposited to maximise interest whilst maintaining a safe and secure investment strategy. This is set out in the Academy's Investment Policy and is actively monitored through the Senior Leadership Team and Finance, Risk and General Purposes Committee.

c. Principal risks and uncertainties

The Academy continues to monitor the government's intention to fully introduce a National Funding Formula from 2021 and is focusing closely on the teacher pay and pension grants and how these will eventually be incorporated into the National Funding Formula. As highlighted in the SRMA report, the school has taken a strategic approach to find efficiencies within its existing staffing structure as a result of natural movement of staff. In addition, we have also taken a number of actions, namely:

- Curriculum budgets have been frozen
- Conducted essential maintenance and repairs in house
- Routinely updated the risk register
- Asbestos management survey and plan routinely updated May 2018 and reviewed May 2019. Due to be reviewed again following completion of current construction works and consequent building demolitions.
- Legionella Risk Assessment conducted October 2018, with re-survey due during academic year 2020/21.
- Multiple surveys of utilities around site prior to building works, resulting in a refresh of existing information
- Other risk areas are the protection of pupils, staff and assets as well as maintaining pupil numbers in order to manage the financial risks. Systems and procedures to minimise these are constantly being reviewed and updated.

RISK MANAGEMENT

The Academy has an ongoing risk management process. Overall responsibility for risk management rests with the Governing Body. The Finance, Risk and General Purposes Committee regularly monitors the types of risk the Academy faces, monitoring any changing levels of risk and identifying newly emerging risks. Current areas for close monitoring include:

- School funding
- Post 16 funding, given the size of the Sixth Form
- The volatility of student numbers for demographic reasons, both at entry Year 9 and post 16
- Provision for alternative curriculum
- The age of some of the school buildings
- Pension cost increases

Day-to-day managing and monitoring of risk is delegated to the Head and the Senior Leadership Team (SLT). The team handle this process through the use of the Academy's Risk Register which has been prepared through wide consultation with all interested parties and using expert external resource. It is subject to regular scrutiny at both executive and non executive levels. It is updated quarterly and is formally scrutinised by the Finance, Risk and General Purposes Committee. The role of the Committee is to challenge the SLT on the identification of risks, the management actions to be taken in mitigation and the residual risks. The Finance, Risk and General Purposes Committee reports the Risk Register to the full Governing Body.

As well as the Risk Register, the school has a Continuity Plan and a Whistleblower Policy in place.

FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Academy has an accountancy management software system, which is embedded into all financial processes.

To support the conversion to an Academy, new accounting software was introduced in 2011 to support enhanced reporting needs, this has now been fully integrated into the academy's financial and management report systems and controls. The Governors review the ESFA Financial Handbook every year to ensure that the Academy is compliant with current ESFA regulations. Risk registers based upon those in the Financial Handbook are in place and monitored by Governors.

The Academy undertakes internal assurance reviews (undertaken by an external third party) into key aspects of the management of the Academy each year. In 2019/20, an SRMA review on behalf of the ESFA took place, and Browne Jacobson reviewed the school's risk assessment in relation to re-opening following the COVID-19 lockdown.

As outlined above, the Risk Register and Business Continuity Plan are reviewed regularly by the Finance Manager, Operations Manager, Senior Leadership Team and the Academy's Governing Body.

d. Other information

The accounting period runs from the 1st September 2019 to 31st August 2020 and the school finished the year with an in-year consolidated surplus of £107,000. This surplus was achieved despite the impact of COVID-19, by ensuring tight financial control over all costs. At the time of writing this report, the school has received £6,800 of additional government funding for expenditure directly incurred due to COVID-19, which we calculated to be in the region of £34,235 during this period. There has also been no source of funding to recover the loss of expected externally generated income, which we calculated to be £32,000.

As the impact of COVID-19 continues to affect external activities, it is likely that a significant proportion of this year's surplus will be absorbed during the next academic year.

The majority of the Academies income is obtained from the ESFA in the form of recurrent grants the use of which is restricted to particular purposes. The grants received from the ESFA during the period ended 31 August 2020 and the associated expenditure are shown as restricted funds in the statement of financial activities. The other key source of funding was from the DFE, £368,000, for our SCITT and Teaching School. The continued support for the SCITT and Teaching School is ensuring that we maintain a good cohort of highly trained students and motivated teaching staff.

The School was also successful with a CIF bid for roof repairs, worth £236,000. Works will commence early in 2021. The pension balance at 31st August 2020 is £2,839,000 (see page 70).

The Governing Body continues to investigate the development of other sources of income.

The Board of Governors would like to thank the sponsors: the John Martin Charity for their kind donations to the academy. In accordance with the Charities statement of recommended practise 'Accounting activities by Charities' (SORP 2019) such grants are shown in the Statement of Financial Activities as restricted income in the fixed asset fund, the restricted fixed asset fund balance will be reduced by annual depreciation charges over the expected useful life of the assets concerned. This funding is used specifically to support disadvantaged students.

Fundraising

Other than fundraising for local charities, including via the students' Interact group, which raised £2,400 from September 2019 to March 2020, and £1,125 raised during the COVID-19 lockdown for the Friends of Evesham Hospital, the school does not participate in the collection of school funds from parents.

- To continue to thoroughly focus upon the progress of Disadvantaged Students
- To implement a rolling programme of classroom refurbishment throughout the year
- To complete the new D&T building, following successful CIF bid
- To complete the roof project through CIF
- To enhance car parking and complete Conference Centre project.

The Full Governing Body meets formally four times per year. Discussions are held and decisions are made or ratified as appropriate. There are three main committees, which meet three or four times per year: Finance, Risk and General Purposes; Safeguarding, Health & Safety, Insurance & Property; and Academic, Pastoral and Teaching. The Audit and Planning Committee meets at least twice a year and the Salaries and Appointments Committee meets as required, but normally at least twice a year. However, due to COVID-19, the summer term meetings of FR&GP, SHIP and APT did not take place and any transactional items requiring approval were undertaken via report and at the Full Governing Body meeting held on 16th June 2020.

During the year, these committees met in person and (during lockdown), virtually, to discuss adherence to plan, to debate developing operational, financial and strategic issues and to support and challenge the Senior Leadership Team in their ongoing management of the performance, direction and strategy of the Academy. Specific work was undertaken in the areas of policy development and strategy with a particular focus on the budgetary constraints due to the delayed implementation of the Fair Funding Formula.

Interim decisions are reached at committee for ratification at Full Governing Body meetings. The day-to-day running of the Academy is delegated to the senior management team who report back to the Governors' committees as appropriate.

All committees are sub committees of the main board of governors as highlighted above. In addition to the Governors, the Academy Operations Manager and Academy Finance Manager attend all relevant meetings.

The effectiveness of governance is reviewed regularly and is included on the Risk Register. This is discussed at the Audit & Planning meeting in December and then reviewed at the annual Members' meeting in January.

To reflect changes stipulated in the Academies Financial Handbook 2020, during summer 2020, the Governing Body agreed that three committees would be re-named and issued with updated Terms of Reference to be

Review of value for money

As accounting officer, the Headteacher has responsibility for ensuring that the Academy delivers good value in the use of public resources. The accounting officer understands that value for money refers to the educational and wider societal outcomes achieved in return for the taxpayer resources received.

The accounting officer considers how the Academy's use of its resources has provided good value for money during each academic year, and reports to the Board of Governors where value for money can be improved, including the use of benchmarking data where appropriate. The accounting officer for the Academy has delivered improved value for money during the year by:

- **Achieving Key Performance Indicators (page 11) to ensure that it is delivering "value for money".**
- **Targeted improvement:** The Trust has kept its staffing structure under review and deployed staff efficiently to support an improved curriculum, or to target areas of the curriculum in need of development. **This has been applicable especially given the sizable cuts to the budget the trust encountered as a result of unintended consequences of the funding formula.** This was also coupled with cuts to the Sixth Form budget.

This is monitored through weekly Senior Leadership Team meetings, Termly Governors' Academic, Pastoral & Teaching meetings and twice-yearly Governors' Salaries and Appointments meetings. There is a yearly Trustees' meeting, which also oversees everything that has been mentioned.

- **Focus on individual pupils:** The Trust has managed the differing needs of pupils, such as those requiring one to one support, and those requiring more stretch. The school is also focussing intently upon students who require catch-up support post lockdown.

This is monitored by the Special Educational Needs Co-ordinator, Assistant Head in Charge of Alternative Curriculum, Deputy Head Curriculum, Senior Leadership Team, and Academic, Pastoral & Teaching Committee Governors' meetings. Ofsted 2013 acknowledged the school is making effective use of our Pupil Premium funding. Ofsted 2014 positively acknowledged that the school chooses appropriate placements for students requiring an alternative provision. HOYs and the Safeguarding Team meets on a weekly basis.

- **Collaboration:** The Trust has engaged with other educational providers and experts to share delivery or good practice, and to drive up standards for the least cost. The Trust is also focused upon working collaboratively with the Worcestershire Teaching School Alliance and has plans to make a formal collaboration agreement with South Bromsgrove High School & The Chase High School.

This is monitored by Senior Leadership Team meetings, Governors' Finance, Risk and General Purposes Committee. We work closely with our feeder Middle and First Schools to share resources eg Education Welfare Officer (EWO) and Educational Psychologist. This has worked effectively, efficiently and we have seen every single school involved with our EWO have an improvement in attendance. We work with our LA to ensure the best services for the best price are provided for the Academy. In addition, the school has access to all the communication available to all the Worcestershire Heads.

As a result of Teaching School Status, the school is now offering reduced cost, high quality CPD provision to our partner schools. The Academy has had SCITT status since September 2017.

- **New initiatives:** In the 2019/20 academic year, the following initiatives were undertaken:
 - o **Teaching School:** We completed the SSIF project for 42 schools across Worcestershire and were recognised by the Department for Education, which used the project as a Case Study. We supported the delivery of NPQH programmes for Worcestershire.
 - o **Inspections:** We received a successful SCITT inspection in November 2019. We also received a successful School Resource Management Visit highlighting that the school was delivering value for money

- o E-Learning: As a result of lockdown, we embarked upon remote learning for all our students through ShowMyHomework and Microsoft Teams. We were also able to delivery online musical concerts, Speech Day and all governors meetings took place online.
- o Pay Award: During the 2019/20 academic year, after full consultation with unions and staff, the school implemented a local pay award for teaching and support staff in January.
- o Staff Restructuring: As part of a succession planning programme, we continued the process of internal restructuring which involved the pastoral and House teams, Citizenship, Business Studies and Psychology Departments. Some restructuring of alternative provision was also undertaken.
- o Curriculum and Timetable: This was re written to allow for enhanced PPA time for Middle Leaders, following the introduction of the pay award. We also revised our curriculum in Modern Foreign Languages.
- o Improved Facilities: The school embarked upon a £3.6M CIF project for an improved Design and Technology Department.
- **Quantifying improvements**: The outcomes obtained by our pupils in 2020 were excellent. Nearly every pupil went to a university of his or her first choice in 2020. In addition, we achieved very high pupil attendance. Pupils' educational attainment, behaviour and attendance records over time are available through the DfE website. A link to this can be found from our website in the Statutory Information Section.
- **Independent monitoring**: Ofsted 2013: The School is providing an "outstanding" quality of education; Ofsted 2014: Alternative provision survey; Ofsted 2015: More Able Pupils national report; RAISEonline Dec 2014; Trustees' financial report prepared by Auditors Randall and Payne 2014; regular review and meetings with School Improvement Partner; Independent external assurance audits of investments and student attendance 2016/17, SCITT and SSIF 2018, Staff Pay Award and RPA 2019. Ofsted Pilot Inspection 2019; Stage One SCITT inspection 2019; Stage 2 SCITT inspection 2019. School Resource Management Advisor Report July 2020. We also changed our Auditors in May 2020 to Crowe UK LLP.
- **Financial governance and oversight**: Good level of Financial Governance as outlined by Ofsted 2013 and Report to Governors by Randall and Payne 2015.
- **Better purchasing**: The Trust has achieved the following to "get more for its money":
 - o **Options appraisal**: Different options have been considered before making purchases, including an assessment of the costs and benefits of the alternatives over the longer term. Tendering has been used appropriately and effectively (eg tendering for the MFL, Science and recent S106 build projects)
 - o **Economies of scale**: The Trust has also taken opportunities to work collaboratively with others to reduce and share services and administration eg Website & marketing provision across the pyramid.
 - o **"Best value"**: Through evaluation of contracts throughout the year by its Operations and Finance Managers, scrutinised prior to expiry, ready for negotiation or re tendering the service for the school (and recently the wider community/ feeder schools). Contracts are set to achieve maximum efficiency and best fit for our needs, whether this is annually, bi annually or longer, with options to extend or terminate at the end. Best value is considered at all times, with all services and suppliers and monitored through our finance office and annual independent audit. This is monitored through weekly Senior Leadership Team meetings, Termly Governors' Finance, Risk & General Purposes meeting, Annual Audit by Crowe.
- **Fitness for purpose**: Services and contracts have been appraised or renegotiated to get the best mix of

quality and effectiveness for the least cost.

Any sufficiently large contract will be put out for tender and processed through an independent company, ensuring full compliance with EU regulations, and best value for money. This may not be considered by the Trust to be the cheapest, but is the most effective for the needs of the school and relevant stakeholders. The Trust always prides itself on choosing the best and most fit for purpose companies to work with. This is monitored through Senior Leadership Team, Finance, Risk and General Purposes and Salaries and Appointments Committees.

- **Benchmarking:** The Trust has benchmarked its costs against similar organisations in relation to its staffing structure, which obviously forms the largest part of the budget.

This is monitored through Senior Leadership Team, Finance, Risk & General Purposes and Salaries & Appointments Committees.

- **Better income generation:** Income is now generated through extended school services ie EWO and Technical Support, at a cost deemed fair to stakeholders/feeder schools and organisations to support the Trust's ongoing good relations. This is monitored through Senior Leadership Team, Finance, Risk & General Purposes and Salaries & Appointments Committees. We also generate an income through lettings of the Sports Hall and Arts Centre facilities.

- **Reviewing controls and managing risks:** The Trust has organised its internal controls to maximise its use of assets. The Senior Team and Governors receive monthly budget reports. The budget is closely monitored to utilise spare resources and prevent waste.

The Trust reviews its controls and managing risk through Senior Leadership Meetings, termly Finance, Risk & General Purposes and Safeguarding, Health & Safety, Insurance & Property Committee meetings. Separate Audit and Planning meetings are held twice a year. The Risk Register is annually reviewed, as are the Critical Incident Plan, school's insurance, handbooks and financial procedures. Bank balances are monitored monthly and when necessary higher interest accounts are used for the accumulation of slightly higher interest rates. The independent external assurance reports and reviews provide recommendations on the above.

The Trust has a Risk Register with a Continuity Plan. As part of the Trust's ongoing review of its risks and how to mitigate these the Academy's overall insurance protection arrangements are now placed using a combination of the Government's Risk Protection Arrangement (RPA) and a number of conventional insurers. Before this change was made, a full risk assessment took place.

- **Lessons learned:** Prince Henry's High School discusses and reviews all aspects of financial spending and risk through Trustee and Committee meetings. Monthly cashflow and Governors' reports are circulated to all members of the Senior Leadership Team and Finance, Risk & General Purposes Committee. The School Development Plan is directly linked to the finances of the Trust and is closely monitored for changes within the school and from external factors such as the Fair Funding Formula. Finally, any independent external assurance advice is sought from Crowe U.K. LLP.

The purpose of the system of internal control

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives. It can, therefore, only provide reasonable and not absolute assurance of effectiveness. The system of internal control is based on an on-going process designed to identify and prioritise the risks to the achievement of Academy policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised, and to manage them efficiently, effectively and economically. The system of internal control has been in place in The Prince Henry's High School Academy Trust for the year 1 September 2019 to 31 August 2020 and up to the date of approval of the annual report and financial statements.

Capacity to handle risk

The Board of Governors has reviewed the key risks to which the Academy is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The Board of Governors is of the view that there is a formal ongoing process for identifying, evaluating and managing the Academy's significant risks that has been in place for the year 1 September 2019 to 31 August 2020 and up to the date of approval of the annual report and financial statements. This process is regularly reviewed by the Board of Governors.

The Trust has organised its internal controls to maximise its use of assets. The Senior Team and Governors receive monthly budget reports. The budget is closely monitored to utilise spare resources and prevent waste.

The Trust reviews its controls and managing risk through Senior Leadership Meetings, termly Finance, Risk and General Purposes and Safeguarding, Health & Safety, Insurance & Property meetings. Separate Audit and Risk meetings are held twice a year. The Risk Register is annually reviewed, as are the Critical Incident Plan, the school's Insurance protections, handbooks and financial procedures. Relevant various sections are reviewed at individual Committee level. Bank balances are monitored monthly and when necessary higher interest accounts are used for the accumulation of slightly higher interest rates. The school normally commissions an independent external assurance report in an internal audit role, which reviews and gives recommendations relating to the above. Due to COVID-19 and the fact that the ESFA commissioned a School Resource Management Advisor review, the internal assurance report was not undertaken in 2020.

The risk and control framework

The Academy's system of internal financial control is based on a framework of regular management information and administrative procedures including the segregation of duties and a system of delegation and accountability. In particular, it includes:

- comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the Board of Governors
- regular reviews by the Finance and General Purposes Committee of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes
- setting targets to measure financial and other performance
- clearly defined purchasing (asset purchase or capital investment) guidelines
- identification and management of risks

The board of trustees has considered the need for a specific internal audit function and has decided not to appoint an internal auditor. However, the Governors have appointed new auditors in 2020 and have additionally appointed Optimum Professional Services to undertake Internal Audit Assurance from September 2020 to perform additional checks.

The reviewer's role includes giving advice on financial matters and performing a range of checks on the

Academy's financial systems. In the last academic year, the ESFA also commissioned a School Resource Management Advisor Visit with a Report to Governing Body. This was very positive.

On termly basis, the reviewer reports to the Board of Governors through the audit committee on the operation of the systems of control and on the discharge of the Board of Governors financial responsibilities and annually prepares a short annual summary report to the committee outlining the areas reviewed, key findings, recommendations and conclusions to help the committee consider actions and assess year on year progress.

Review of effectiveness

As accounting officer, the Headteacher has responsibility for reviewing the effectiveness of the system of internal control. During the year in question the review has been informed by:

- on discharge of the Board of Governors financial decisions to help the committee consider actions and assess year on year progress
- the work of the reviewer;
- the work of the external auditor;
- the work of the executive managers within the Academy who have responsibility for the development and maintenance of the internal control framework.

The accounting officer has been advised of the implications of the result of their review of the system of internal control by the audit committee and a plan to address weaknesses and ensure continuous improvement of the system is in place.

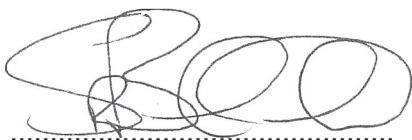

1. Accounting policies

A summary of the principal accounting policies adopted (which have been applied consistently, except where noted), judgments and key sources of estimation uncertainty, is set out below.

The company is a private company (limited by guarantee), which is incorporated and registered in England and Wales (no. 07512962). The address of the registered office is Victoria Avenue, Evesham, Worcestershire, WR11 4QH.

1.1 Basis of preparation of financial statements

The financial statements of the Academy Trust, which is a public benefit entity under FRS 102, have been prepared under the historic cost convention in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland (FRS 102), the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)), the Academies Accounts Direction 2019 to 2020 issued by ESFA, the Charities Act 2011 and the Companies Act 2006.

The Prince Henry's High School Academy Trust meets the definition of a public benefit entity under FRS 102.

The Trust is the ultimate parent undertaking, having 100% control of PHHS Trading Company Limited, a company limited by guarantee and registered in England and Wales.

The subsidiary operates for trading activities that fall outside of the primary purpose of the Trust. All activities have been consolidated in the statement of financial activities.

The Consolidated Statement of Financial Activities (SOFA) and Consolidated Balance Sheet consolidate the financial statements of the Academy and its subsidiary undertaking. The results of the subsidiary are consolidated on a line by line basis.

The Academy has taken advantage of the exemption allowed under section 408 of the Companies Act 2006 and has not presented its own Statement of Financial Activities in these financial statements.

No separate SOFA has been presented for the Academy alone as permitted by section 408 of the Companies Act 2006.

1.2 Going concern

The Governors assess whether the use of going concern is appropriate i.e. whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the Academy to continue as a going concern. The Governors make this assessment in respect of a period of at least one year from the date of authorisation for issue of the financial statements and have concluded that the Academy has adequate resources to continue in operational existence for the foreseeable future and there are no material uncertainties about the Academy's ability to continue as a going concern, thus they continue to adopt the going concern basis of accounting in preparing the financial statements.

1.3 Income

All incoming resources are recognised when the Academy Trust has entitlement to the funds, the receipt is probable and the amount can be measured reliably.

- **Grants**

Grants are included in the Consolidated Statement of Financial Activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance Sheet. Where income is received in advance of meeting any performance-related conditions there is not unconditional entitlement to the income and its recognition is deferred and included in creditors as deferred income until the performance-related conditions are met. Where entitlement occurs before income is received, the income is accrued.

General Annual Grant is recognised in full in the Consolidated Statement of Financial Activities in the year for which it is receivable and any abatement in respect of the year is deducted from income and recognised as a liability.

Capital grants are recognised in full when there is an unconditional entitlement to the grant. Unspent amounts of capital grants are reflected in the Balance Sheet in the restricted fixed asset fund. Capital grants are recognised when there is entitlement and are not deferred over the life of the asset on which they are expended.

- **Sponsorship income**

Sponsorship income provided to the Academy Trust which amounts to a donation is recognised in the Consolidated Statement of Financial Activities in the year in which it is receivable (where there are no performance-related conditions) where receipt is probable and it is measurable.

- **Donations**

Donations are recognised on a receivable basis (where there are no performance-related conditions) where the receipt is probable and the amount can be reliably measured.

- **Other income**

Other income, including the hire of facilities, is recognised in the year it is receivable and to the extent the Academy Trust has provided the goods or services.

1.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

- **Expenditure on raising funds**

This includes all expenditure incurred by the Academy Trust to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

- **Charitable activities**

These are costs incurred on the Academy Trust's educational operations, including support costs and costs relating to the governance of the Academy Trust apportioned to charitable activities.

All resources expended are inclusive of irrecoverable VAT.

1.5 Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the Academy Trust; this is normally upon notification of the interest paid or payable by the institution with whom the funds are deposited.

1.6 Taxation

The Academy is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes.

Accordingly, the Academy is potentially exempt from taxation in respect of income or capital gains received within categories covered by Part 11, chapter 3 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

1.7 Tangible fixed assets

Assets costing £500 or more are capitalised as tangible fixed assets and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or from the private sector, they are included in the Balance Sheet at cost and depreciated over their expected useful economic life. Where there are specific conditions attached to the funding requiring the continued use of the asset, the related grants are credited to a restricted fixed asset fund in the Consolidated Statement of Financial Activities and carried forward in the Balance Sheet. Depreciation on the relevant assets is charged directly to the restricted fixed asset fund in the Consolidated Statement of Financial Activities. Where tangible fixed assets have been acquired with unrestricted funds, depreciation on such assets is charged to the unrestricted fund.

Depreciation is provided on all tangible fixed assets other than freehold land and assets under construction, at rates calculated to write off the cost of each asset on a basis over its expected useful life, as follows:

Depreciation is provided on the following bases:

Freehold property	- 120 Years Straight Line (Buildings) & 10 Years Straight Line (Temporary Structures)
Furniture and fittings	- 5 Years Straight Line
Plant and machinery	- 7 Years Straight Line
Computer equipment	- 4 Years Straight Line

Assets in the course of construction are included at cost. Depreciation on these assets is not charged until they are brought into use and reclassified to freehold or leasehold land and buildings.

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Consolidated Statement of Financial Activities.

1.8 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

1.9 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

1.10 Liabilities and provisions

Liabilities and provisions are recognised when there is an obligation at the Balance Sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the Academy Trust anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide. Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised within interest payable and similar charges.

1.11 Financial instruments

The Academy Trust only holds basic financial instruments as defined in FRS 102. The financial assets and financial liabilities of the Academy Trust and their measurement bases are as follows:

Financial assets - trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost as detailed in note 16. Prepayments are not financial instruments. Amounts due to the Academy's wholly owned subsidiary are held at face value less any impairment.

Cash at bank is classified as a basic financial instrument and is measured at face value.

Financial liabilities - trade creditors, accruals and other creditors are financial instruments, and are measured at amortised cost as detailed in note 17. Taxation and social security are not included in the financial instruments disclosure definition. Deferred income is not deemed to be a financial liability, as the cash settlement has already taken place and there is an obligation to deliver services rather than cash or another financial instrument. Amounts due to the Academy's wholly owned subsidiary are held at face value less any impairment.

1.12 Operating leases

Rentals paid under operating leases are charged to the Consolidated Statement of Financial Activities on a straight line basis over the lease term.

1.13 Pensions

Retirement benefits to employees of the Academy Trust are provided by the Teachers' Pension Scheme ("TPS") and the Local Government Pension Scheme ("LGPS"). These are defined benefit schemes.

The TPS is an unfunded scheme and contributions are calculated so as to spread the cost of pensions over employees' working lives with the Academy Trust in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary on the basis of quadrennial valuations using a prospective unit credit method. TPS is an unfunded multi-employer scheme with no underlying assets to assign between employers. Consequently, the TPS is treated as a defined contribution scheme for accounting purposes and the contributions recognised in the period to which they relate.

The LGPS is a funded multi-employer scheme and the assets are held separately from those of the Academy Trust in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit credit method and discounted at a rate equivalent to the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each Balance Sheet date. The amounts charged to operating surplus are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability/asset is also recognised in the Consolidated Statement of Financial Activities and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other recognised gains and losses.

Actuarial gains and losses are recognised immediately in other recognised gains and losses.

1.14 Agency arrangements

The Academy Trust acts as an agent in distributing 16-19 bursary funds from ESFA. Payments received from ESFA and subsequent disbursements to students are excluded from the Statement of Financial Activities as the Trust does not have control over the charitable application of the funds. The Trust can use up to 5% of the allocation towards its own administrative costs and this is recognised in the Statement of Financial Activities. The funds received and paid and any balances are disclosed in note 29.

1.15 Fund accounting

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of the Academy Trust at the discretion of the Governors.

Restricted fixed asset funds are resources which are to be applied to specific capital purposes imposed by the funders where the asset acquired or created is held for a specific purpose.

Restricted general funds comprise all other restricted funds received with restrictions imposed by the funder/donor and include grants from the Department for Education Group.

Investment income, gains and losses are allocated to the appropriate fund.

2. Critical accounting estimates and areas of judgment

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Critical accounting estimates and assumptions:

The Academy makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost or income for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 25, will impact the carrying amount of the pension liability. Furthermore a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2019 has been used by the actuary in valuing the pensions liability at 31 August 2020. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

Critical areas of judgment:

Fixed asset valuations have been included at their estimated fair value at the date of conversion, and depreciated over their useful life since. With no formal valuations occurring since this date, the judgment is to assess whether this valuation is still appropriate in the accounts.

3. General Annual Grant (GAG)

Under the funding agreement with the Secretary of State, the academy trust was subject to limits at 31 August 2020 on the amount of GAG that could be carried forward from one year to the next. An amount equal to 12% of GAG could be carried forward, of which up to 2% could be used for general recurrent purposes, with any balance being available for premises/capital purposes.

The academy trust has not exceeded these limits during the year ended 31 August 2020.

The Academy's employees belong to two principal pension schemes: the Teachers' Pension Scheme England and Wales (TPS) for academic and related staff; and the Local Government Pension Scheme (LGPS) for non-teaching staff, which is managed by Mercer. Both are multi-employer defined benefit schemes.

The latest actuarial valuation of the TPS related to the period ended 31 March 2016 and of the LGPS 31 March 2019.

There were no outstanding or prepaid contributions at either the beginning or the end of the financial year.

Teachers' Pension Scheme

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for full-time teachers in academies. All teachers have the option to opt-out of the TPS following enrolment.

The TPS is an unfunded scheme to which both the member and employer makes contributions, as a percentage of salary - these contributions are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

Valuation of the Teachers' Pension Scheme

The Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury every 4 years. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31 March 2016. The valuation report was published by the Department for Education on 5 March 2019. The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 23.68% of pensionable pay (including a 0.08% administration levy)
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £218,100 million and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £196,100 million, giving a notional past service deficit of £22,000 million
- the SCAPE rate, set by HMT, is used to determine the notional investment return. The current SCAPE rate is 2.4% above the rate of CPI, assumed real rate of return is 2.4% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.2%. The assumed nominal rate of return including earnings growth is 4.45%.

The next valuation result is due to be implemented from 1 April 2023.

The employer's pension costs paid to TPS in the year amounted to £826,345 (2019 - £559,576).

Under the definitions set out in FRS 102, the TPS is an unfunded multi-employer pension scheme. The Academy Trust has accounted for its contributions to the scheme as if it were a defined contribution scheme. The Academy Trust has set out above the information available on the scheme.

Local Government Pension Scheme

The LGPS is a funded defined benefit pension scheme, with the assets held in separate trustee-administered funds. The total contribution made for the year ended 31 August 2020 was £260,000 (2019 - £243,000), of which employer's contributions totalled £216,000 (2019 - £201,000) and employees' contributions totalled £ 44,000 (2019 - £42,000). The agreed contribution rates for future years are 19.1 per cent for employers and 6.5 per cent for employees.

Parliament has agreed, at the request of the Secretary of State for Education, to a guarantee that, in the event of academy closure, outstanding Local Government Pension Scheme liabilities would be met by the Department for Education. The guarantee came into force on 18 July 2013.

27. Members' liability

Each member of the charitable company undertakes to contribute to the assets of the company in the event of it being wound up while he/she is a member, or within one year after he/she ceases to be a member, such amount as may be required, not exceeding £NIL for the debts and liabilities contracted before he/she ceases to be a member.

28. Related party transactions

Owing to the nature of the Academy and the composition of the Board of Governors being drawn from local public and private sector organisations, transactions may take place with organisations in which the governors have an interest. All transactions involving such organisations are conducted in accordance with the requirements of the Academies Financial Handbook, including notifying the ESFA of all transactions made on or after 1 April 2019 and obtaining their approval where required, and with the Academy's financial regulations and normal procurement procedures relating to connected and related party transactions.

The following transactions took place in the period of account:

Westacre Middle School - in which the wife of governor Dr A Evans is a governor. Staff services for EWO were invoiced for £3,860 (2019: £3,785). Payments for support work totalling £nil (2019: £2,040) were made to the school. There were no amounts outstanding as at 31 August 2020 (2019: £nil). The services were invoiced at the normal commercial rate.
