The Art and Textiles department are organising a trip for Year 10 Art and Textiles students to visit the Tate Modern Art Gallery, in London, on **Thursday, 23 May 2024**. As part of the GCSE Art and Textiles course students are required to research the work of artists and designers. This trip will give students a valuable opportunity to see artwork first hand and carry out research for their Year 11 Mock Exam project.

We will be leaving for London by coach from Prince Henry's at **9.15 am** and will aim to return at approximately **7.30 pm** (exact time to be confirmed). Students will be reminded that they should wear a seatbelt whilst travelling on the coach. Students do not need to wear school uniform but they should dress appropriately for the weather and wear sensible footwear. Students will need to provide their own lunch and it is suggested that they also bring with them a small amount of money to buy postcards or souvenirs. Students will be given unsupervised time to wander around the gallery and whilst doing so students must remain in groups of no less than 3.
