Dear Parents/Carers,

I am writing to give details and the cost of Music Lessons available for 2025-2026.

Lessons are provided for 33 weeks of the year, they last for 30 minutes and take place mostly during school hours. Each weekly instrument lesson works on a rota basis, so pupils do not miss the same curriculum lesson each week.

In the event of a child missing a lesson due to circumstances other than sickness, they need to inform their tutor who will try to re-schedule the lesson. In the event of severe weather or teacher absence the teacher will attempt to re-schedule the lesson.

During exam periods, it is the responsibility of students to speak to their teacher to arrange an alternative time for their lesson.

It is the responsibility of the parents/carers of students in Years 11, 12 and 13 to ensure their child attends lessons during study leave and after the exams until the end of the school year.

This year we are able to offer both individual and group lessons (subject to instrument). Availability of group lessons cannot be guaranteed and are only available if there are 2 students, playing the same instrument and of the same ability wanting to have group lessons. Group lessons are available for all instruments apart from drums and piano.

If your child would like to receive music lessons through school, please complete the attached contract and return it to school by **Monday 7th July 2025**. Contracts can either be returned to student reception in school or by email to **finance@princehenrys.worcs.sch.uk**.

The deposit fee will be allocated to your Parentpay account in September and must be paid by Friday 26th September 2025. Failure to pay the correct deposit by this date will result in music tuition being withdrawn with immediate effect. The remaining fees can be paid in 5 monthly instalments from October 2025 to February 2026.

For families on low income/free school meals there may be the possibility of some financial help with the cost of tuition. Please contact the school finance office by email for further details at **finance@princehenrys.worcs.sch.uk**. This email address should also be used for information on instrument hire.

All accompanists for Associated Board music examinations are the responsibility of the student. For further details please see Mr Bullas.

Music Tuition Contract 2025-2026

Prince Henry's High School undertake to provide a minimum of 33 lessons of music tuition during the Academic Year (September 2025 to July 2026).

The following terms and conditions will apply:

1. Initial deposit to be paid by Friday 27th September 2025 followed by five monthly instalments between October 2025 and February 2026. Non-payment may result in music tuition being withdrawn and, if necessary, legal proceedings started to recover all monies owed to the school.
2. **If a student wishes to end lessons a minimum of a half term's notice is required in writing to Mr Bullas.**
3. No refunds will be given to students who cease tuition before the end of the academic year or to those who fail to attend lessons, unless written confirmation has been given (as above). Consideration may be given to granting a refund if absence is due to a prolonged illness or incapacity, in which case, a medical certificate should be taken to Mr Bullas at the earliest opportunity.
4. If a lesson does not take place due to school closure or tutor absence the school will endeavour to reschedule the lesson at the earliest opportunity either face to face or via remote tuition.
5. A report will be provided by either Severn Arts Music Service or Prince Henry's High School on the student's progress towards the end of the academic year.
6. If the student is involved in one of the ensembles they will be expected to attend. This will involve a regular commitment to both rehearsals and concerts.
7. **It is the responsibility of the parents/carers of students in Years 11, 12 and 13 to ensure their child attends lessons during study leave and after the exams until the end of the school year.**
